Definitive Plan Submission	\$2,000.00*
*plus two (\$2.00) dollars per linear foot of proposed roadway, measured on the centerline	
Definitive Plan Filed within seven (7) months after a Preliminary Plan	\$1,000.00*
*plus one (\$1.00) dollar per linear foot of proposed roadway measured on the centerline	
Recision of an Approved Definitive Plan	\$500.00
