Mr. Ryan moved to support Article 51 as written. Mr. Hawkes seconded the motion and it was passed. 4:0:1. Mr. Burke abstained.

At 6:58 p.m. Mr. Hawkes moved to adjourn. Mr. Ryan seconded the motion and it was passed unanimously.
