## **MINUTES**

<u>VOTE</u>: Bob made a motion to approve the minutes of February 26, 2018, Rick seconded. The vote was unanimous.

## **INVOICES**

#### UPDATE ON ISHOPP PROJECT APPLICATION

Cortni spoke with Bill Wrigley and Town Council to see if the iShopp project would fit into the four corners of the already existing Deed Restriction Program. Town Council decided that it in fact does and they will provide their opinion in writing. There was concern over Town Meeting voting it down and then nothing could be done with the iShopp program. Jim Salvie also voiced his concerns.

<u>VOTE</u>: Bob made a motion to place the Historic Randall Library Building article on the warrant and to endorse the article to Town Meeting, Ernie seconded. The vote was unanimous.

<u>VOTE</u>: Bob made a motion to approve the Town Hall design funds article as rewritten, Ernie seconded. The vote was unanimous.

**<u>VOTE</u>**: Bob made a motion to place both Town Hall articles on the warrant and to endorse the articles to Town Meeting, Ernie seconded. The vote was unanimous.

**<u>VOTE</u>**: Bob made a motion to submit all CPC Warrant Articles to the Board of Selectman, Ernie seconded. The vote was unanimous.
