The meeting was called to order at 7:01 PM.

Reserve Fund Transfers:

Highway department requesting \$9,000 to cover additional cost for fuel for the Town Fleet. HIghway has used more fuel than average due to the snowstorm which took down many trees and limbs. AT motioned to approve the request for \$9,000 for fuel. PMcL seconded. Unanimously approved 7:08PM

Board of Selectmen Administrative Assistant and Secretary requesting \$600 for longevity bonuses. It was determined that both are eligible for this bonus per the Town's Personnel bylaws. This amount was not in their budget as they did not determine that they were eligible until May 2018. AT motioned to approve the request for the \$600 longevity bonus. PMcM seconded. Members spent some time reviewing the past year's successes as well as explored areas for improvement. Fincom members will be reviewing the Charter and setting up goals and timelines for the upcoming year.
