### Meeting Minutes - 6/28/18

Conray made a motion to approve the 6/28/18 minutes as submitted. Don seconded. All in favor. Motion passed.

## Pay Bills

- Conray submitted a Solitude bill for ongoing services. This was expected by Conray. Andy has the contract details if needed. Kris motioned to approve the Solitude milestone billing of 7/1/18 for \$2,194. Don seconded. All in favor. Town split is \$731.34 Hudson, \$1462.66 Stow.
  - o Action Conray will get a copy of the contract for future reference.
- Conray submitted a bill for Patrol boat gas. Conray motioned to reimburse him in the amount of \$42.07. Kris Seconded. All in favor. Motion passed.
- Conray commented that Hudson reported that a prior Solitude bill had been submitted late to them.

#### Discuss LBC By-Law/Rules review (V0.6) - Next Steps

- Don would like to get to a final recommendation from this meeting for going into a future public info meeting.
- Considering scheduling a public meeting in the Fall, and would make the draft available publicly prior to that.
- V0.6 of the draft revised for the Bylaws & Rules was discussed, addressing only those rules where the commission had no already agreed to a position. Key commissioner input included:

## **General Regulations:**

- o Rule No. 1 Include Marijuana. Town administrator agreed. Strike 'or drink'. Enforcement is at the discretion of the police.
- Rule 2 ok as drafted
- o Rule No. 3 ok as drafted
- o Rule No. 6 Town Admin suggests keeping & LBC agrees
- o Rule No. 7 incorporate marijuana
- o Rule No. 9 ok as drafted

### **Boating Regulations:**

- o Intro paragraph proceed with option 2 with the addition of 'laws &' regulations
- o Rule 1. Speed (A) Add 'property damage'. Conray is dissenting.
- o Rule 1 (D) Leave as drafted with the inclusion of all MA State holidays. Conray dissenting, and would prefer to limit it to Memorial Day, Independence Day & Labor Day.
- o Rule 2. Water Skiing & Towing (A) leave as drafted
- o Rule 3. Boats (B) leave as drafted

- Action: Kris to update the Draft Bylaws Revisions document to reflect the final recommendations. (V0.7)
- Additional comments from the public were entertained during the discussion
- Kris suggested that the LBC commit to finding ways to provide education/reminders of key state regulations without putting them into the By Laws. This could include documents on LBC & LBA websites, postings at public beach & launch sites, and copies made available at the Stow & Hudson Town Offices. The LBC agreed to this strategy.

#### **New Business**

- Comment by Conray- Stow Police Boat is not in the water. No idea what the plan is.
  - o Action Don to check with Stow Police Chief.

**Date of Next Meeting** – Oct 17 LBC meeting was proposed and set a date for public info meeting for Nov 14. Action – Kris to add these to the Stow website calendar.
