Lake Boon Commission Meeting Minutes June 9, 2020

• Conray submitted bills for \$521.95, for the following expenses:

Buoy lights to replace failing lights	\$137.85
Replacement buoy for Indian point	\$329.99
Repair gas tank fittings on patrol boat	\$21.98
Gas for LBC boat	\$32.13
Total to reimburse	\$521.95

- Kris noted that we have only \$500 in the budget, this exceeds that by \$21.95. We discussed whether this balance included the Hudson allocation, and didn't know for sure.
- Dan moved and Kris seconded that we approve the expenses, contingent on confirming the balance available to cover the expense. The motion passed unanimously.

MVP Grant Proposal -

- Dan gave an update on the grant proposal for MA Municipal Vulnerability Program, with proposals due June 11, 2020.
- Dan reported that the narrative and forms were now completed, and incorporated edits provided by Kris and other reviewers.
- Dan reported that all approvals from Stow and Hudson are now confirmed, with letters of support
- We discussed the role of LBC, and confirmed that Stow is the applicant, LBA is the operational lead, Steering Committee oversees. Steering Committee will provide reports to LBC
- No further edits required.

- We reviewed edits to the letter
- Kris moved and Conray seconded approval to submit the proposal and approval of the letter of support. This passed unanimously.

Weed treatment update -

- Conray reported that the weed treatment will take place on June 12, 2020, and that Andy Pollack had posted signs, with the following restrictions:
 - o Swimming, boating, and fishing –Until June 13, 2020 in basins 2, 3
 - o Livestock watering –Until June 13, 2020 in basins 2, 3
 - O Direct drinking –Until June 15, 2020 in basins 2, 3, 4
 - o Irrigation Until June 17, 2020 in basins 2, 3
- We discussed an individual who wanted to have a small boat parade on June 12, 2020. That won't violate the restrictions schedule.
