Minutes of the May 2, 2019 Planning Board Meeting

Lori Clark called the meeting to order at 6:00pm.

Vote to Accept Performance Guarantee, Jillian's Lane

Present:

Nancy Allen-Scannell, Applicant

Jesse Steadman said the applicant has requested a reduced bond amount of \$23,500, which accounts for 150% of the estimate to be held in the account. The cost of procuring as-built plans and installing property bounds has been removed from the estimate. Jesse Steadman clarified that the estimate is not impacted by the enforcement order issued by the Conservation Commission.

The Board discussed whether the as-built plans may be excluded from the estimate, as the plans have not been paid for in full and they cannot be completed until the project is finished. The Board acknowledged that withholding the second Certificate of Occupancy provides the Town leverage to have the work completed, and recognized that this subdivision is unique in its scale.

Karen Kelleher moved to accept the bond reduced from \$37,500 to \$23,500, with the understanding that a deposit has been made to Ducharme & Dillis, that Ducharme & Dillis will install the property bounds, and the Certificate of Occupancy will be held for Lot 2 until the work is completed. Len Golder seconded.

Len Golder moved to authorize one Board member to sign the escrow agreement. Karen Kelleher seconded.

Lower Village Traffic Safety Improvement Project

The Planning Board reviewed the revised draft Design Basis Report and additional scope of services proposal from Green International, as well as Places Associates' comments on the report. The Board discussed Green's findings and recommendations for the closed drainage system, roadway grading, and impacts to abutting properties. The Board agreed that the Article 34 request at Town Meeting should be updated to \$137,500 to reflect funds needed to complete the design phase of the

project and other incidental costs such as peer review and legal fees, with a follow-up Special Town Meeting to be scheduled for June to request the needed construction funds.
