# Meeting called to order at 6:30pm designLab Updates

Schedule Review Check in on where we are in the overall schedule.

- Review meetings with Town departments: Fire, Police, Green Advisory Committee, Traffic & Parking, Zoning and Facilities. Meetings have initiated many processes due at this stage of the design.
- Presentation of newest program plan revisions including a recap of feedback from the EDC meeting on May 3<sup>rd</sup> and new layout eliminating the second-floor terrace outside children's area. Also included were 3D views of some interior spaces.
- Revisited some adjustments to landscaping.
- Discussion/Observations from committee members

## **MEPFP** Presentation

- **HVAC** Air Handling, Heat Pumps and Boilers.
- Brief explanation of the pending article for Town Meeting on what is called the specialized stretch codes for energy use. Reminder that the code will not directly influence this project.
- Electrical Strategy is energy conservation. LED lighting, photosensors for activity in spaces, photocells that read the ambient sunlight and adjust the interior lighting. Complete service upgrade for electric (and gas if chosen)
- Fire Protection Reviewing 2 options: large water storage tank with pump distributing water to the sprinkler system, installation is proving to be a challenge on our site; or, water mist fire protection akin to sprinkler heads but are used in high value areas where you don't want total soak/destruction. Uses 1/10<sup>th</sup> of the water. Requires mechanics that can create the pressure forcing the water into mist. Cost is higher but equivalent over all when considering the cistern system under consideration.

Discussion of the two fire suppression options.

- EFI Global is beginning their investigation
- Skimmed updates already presented by designLab of joint meetings
- Collier's is under contract with a cost estimator: Rider Levitt Bucknell
- Looking forward : more with Green Advisory Committee, septic inspections, soil testing

- Will hire a commissioning agent for MEPFP
- Cost estimates due in June, meeting with both estimators to be sure all pricing is on equal footing
