That the Cemetery Committee of the Town of Stow in the County of Middlesex, and Commonwealth of Massachusetts in consideration of https://www.fee.lib.com/gdollars/paid to them by
the receipt whereof is hereby acknowledged, do hereby grant, bargain, sell and convey to said

and heirs, one lot of land in Brookside Cemetery in said Town of Stow, situated
with the sole and exclusive right of burial of the dead therein.
The said lot contains aboutsuperficial square feet and is numbered. 69 on the plan of the cemetery, which is in the possession of the committee having the superintendence and management thereof, and may be inspected at all reasonable times.
To have and to hold the aforesaid premises muto the said
To have and to hold the aforesaid premises rato the said.

First, That the said lot shall not be used for any other purpose than as a place of burial for the human dead. No trees within the lot or border shall be cut down or destroyed without the consent of said committee, nor shall any change be made in the grade of lots except with the approval and under the direction of the Superintendent, who may make such changes, when, in the opinion of the committee it becomes necessary for the improvement of the cemetery.
Second, That the proprietors of said lots shall have the right to erect monuments, cenotaphs or stones commemorative of the dead; but the foundations of all monuments and stones must have the approval of the Cemetery Committee, and the planting of all trees and shrubs shall be under their direction.
Third, That the Cemetery Committee shall have the right to remove from any lot such trees or shrubs as shall be in their judgment detrimental to adjacent lots or avenues, or in any way dangerous or inconvenient.
Fourth, That all lots shall be indivisible.
Fifth, That any remains of the dead deposited in said lots shall never be removed without the consent of the Cemetery Committee.
Sixth, That the said lot shall be holden subject to all the by-laws, rules and regulations made or to be made by the Cemetery Committee.
Seventh, That all sums received for the sale of lots shall be expended for the general improvement and care of the Cemetery.  And the said Cemetery Committee of the Town of Stow hereby covenant to and with the said
