



To see if the Town will vote to amend the Zoning Bylaws, Section 3.2.2 (uses requiring a special permit from the Board of Appeals in the Residential District), by adding a new subsection 3.2.2.9, to read as follows:

3.2.2.9 Landscaping Businesses and Contractors Yards, including material and vehicle storage, cultivation of plant materials, greenhouses, wholesale and retail sales, provided that the Special Permit Granting Authority shall consider the historic use of the subject site and existing structures.

NOTE: For an Annual Town Meeting, ten registered voters' signatures are required to be certified.  
 For any Special Town Meeting, one hundred registered voters' signatures are required to be certified.  
 To Petition the Select Board to hold a Special Town Meeting, two hundred registered voters' signatures are required to be certified.
