 - *MUST provide proof of current rabies cert
 - Fee \$10.00
 - Unaltered Fee \$10.01
 - Late Fee of \$25 per dog assessed after April 15th

 - ** PLEASE LET US KNOW IF ANY OF YOUR DOG(S) NO LONGER LIVE IN STOW (MOVED/DECEASED/ETC)

- Ability to update/correct info for your dog(s)
- Add new dogs /update status for moved/deceased
- Ability to upload new rabies certificate
- Do not have to supply envelope/postage
- Do not have to fill out this form & find your checkbook
- License(s) will be processed and mailed to you

There is a small bank fee to license online .50¢ - \$1.00 BUT you do NOT have to supply an envelope with extra postage.
